# Ensure the Sustainability of the Association: Choose Planned Giving

Planned giving is a type of charitable donation resulting from financial and/or estate planning. It involves giving, during your lifetime or upon death, a portion of the assets accumulated over your life to a cause, considering your personal, family, and tax situation.

Making a planned gift is a powerful and lasting way to support a cause dear to you while enjoying significant tax benefits for yourself or your estate. This gesture will allow Leucan to continue providing essential support to children with cancer and their families throughout Quebec.

Among the most recognized types of planned gifts are: **bequest in a will, life insurance policy donation and donating listed securities (gift of shares)**.



# Bequest in a Will

A bequest in your will is your legacy to a cause close to your heart. Different types of bequests are available:

- A specific amount;
- A percentage % of your estate after debts, taxes, and specific bequests;
- The entirety of your estate.

You can also name Leucan as a contingent beneficiary in case of the death of a primary beneficiary.

## → Did you know?

In addition to being accessible to everyone, a bequest allows your estate to benefit from significant tax reductions without any cost to you or your estate.

# Life Insurance Policy Donation

Another way to give upon death and leave a larger legacy than what it would cost you to you is by naming Leucan as the beneficiary of a life insurance policy (existing or new). The capital paid to Leucan upon death is often greater than the total premiums you paid during your lifetime.

With this type of gift, you can decide whether to benefit from a tax credit during your lifetime or allow your heirs to benefit from the credit advantage.



## Donating Listed Securities (Gift of Shares)

Transferring your publicly traded securities (gift of shares) is another way to support a cause dear to you. You will benefit from a capital gains tax exemption *in addition* to the charitable donation tax credit.

## Tax Advantages

Planned gifts offer numerous tax benefits, such as:

- Charitable donation tax credit;
- Capital gains tax exemption;
- Reduced estate costs.
